They have the ability to go a little bit above appraisal, 5-10% is the rule, but do not advocate it and do not do it as practice. As far as Cap and Trade goes, they have tried to get the State to take a more expansive view of those funds and how those funds are allocated towards acquisition for carbon sequestration.


